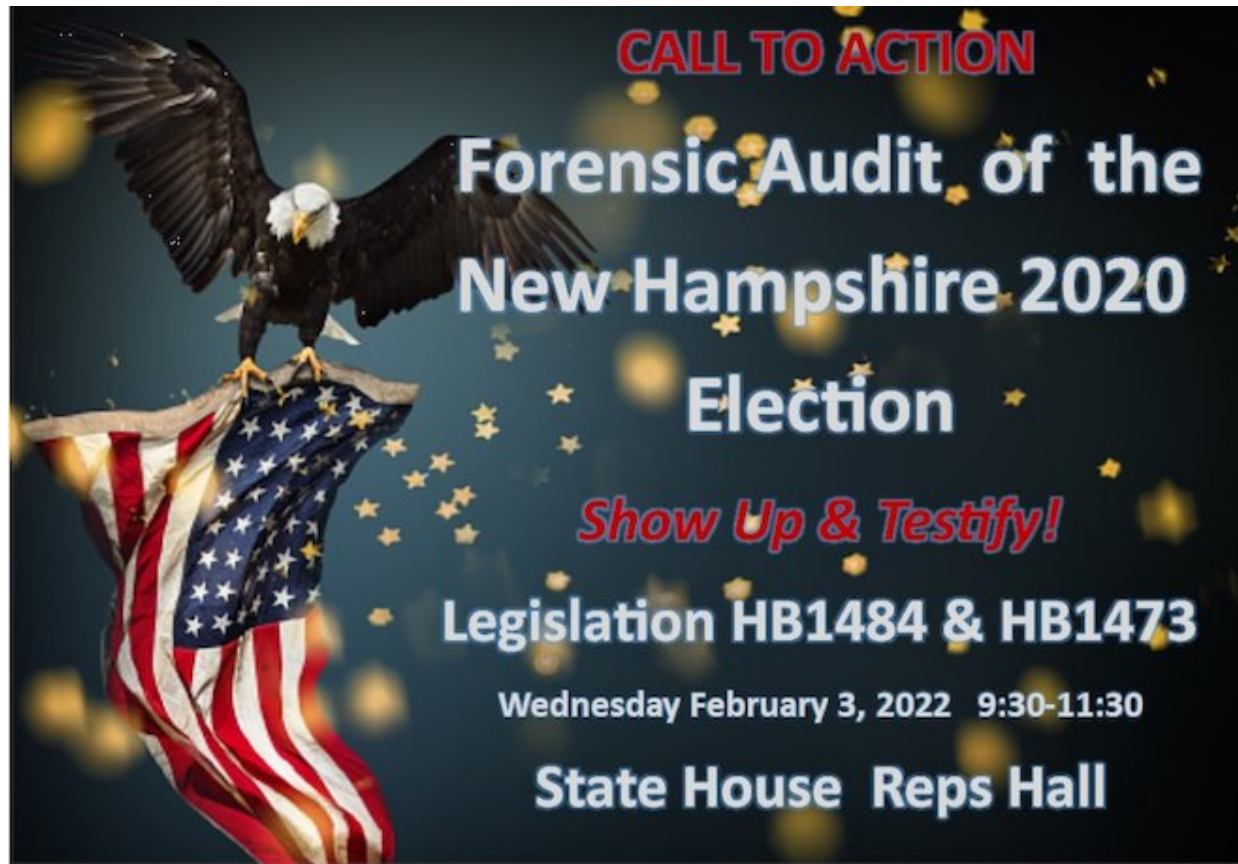

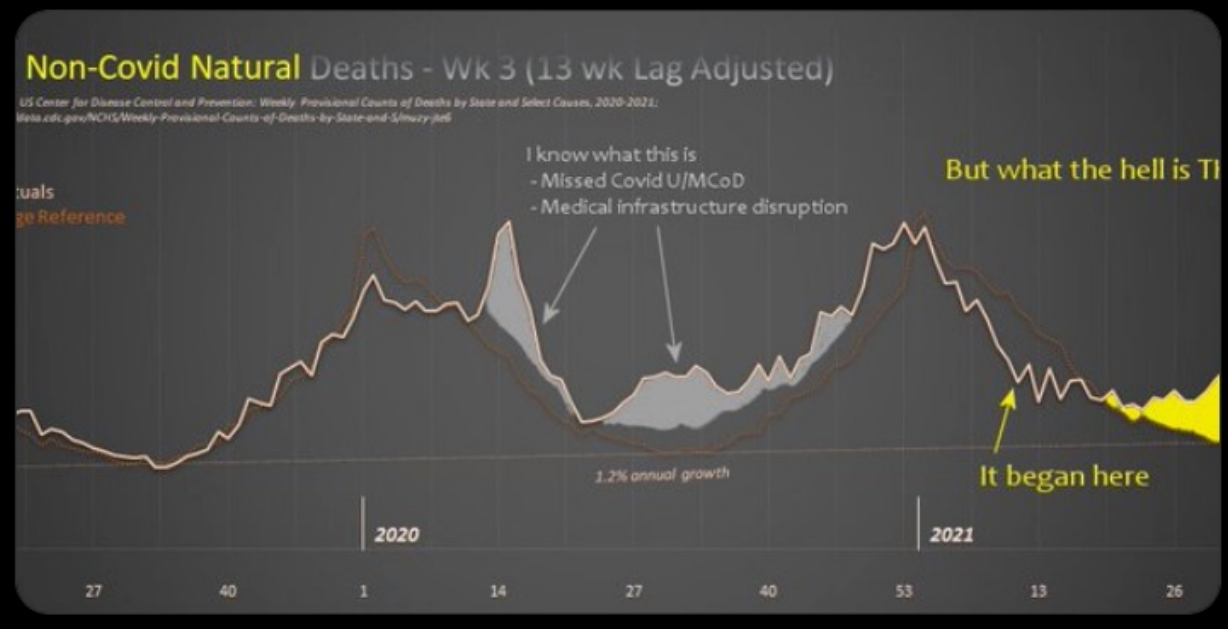

Monday, January 31st | N.H. House of Representatives

10 a.m. – OPPOSE – [HB 1126](#), permitting minors over the age of 16 to obtain a vaccination without parental consent. We'd ask rhetorically, "Are they nuts?," but when we look at the bill sponsors and note that Rep. Bill Marsh is among them, we already know the answer. This bill is as bad as the title makes it out to be. Children of this age group are very impressionable and need their parents to protect them from health officials and school officials who mean them harm. [Click here to register your disposition](#). Tuesday, February 1st | N.H. House of Representatives

9:30 a.m. – SUPPORT – [HB 1224](#), prohibiting state and local governments from adopting certain mandates in response to COVID-19; and prohibiting employers and places of public accommodation from discriminating on the basis of vaccination status. This bill prohibits governments from requiring masks or other facial coverings, from issuing immunity

passports or similar "papers" for vaccination status, and from requiring documentation of COVID-19 vaccination status, and it prohibits discrimination on the basis of COVID-19 vaccination status by places of public accommodation. 10:45 a.m. – SUPPORT – [HB 1604](#), including state medical facilities in the statute providing medical freedom in immunizations. This bill repeals the exemption of government nursing homes, hospitals and medical facilities from the statute pertaining to medical freedom in immunizations. 1 p.m. – SUPPORT – [HB 1003](#), prohibiting health care providers from refusing to provide care or services based on patient vaccination status. Sadly, this bill is very much needed to protect unvaccinated citizens from being treated as second-class citizens. [Click here to register your disposition](#). [Email the committee](#).

2:30 p.m. – SUPPORT – [HB 1099](#), prohibiting the department of health and human services from requiring vaccine passports for services. While this bill could be broader to prohibit discriminatory vaccine passports across the board, it is a start to prohibit the State from getting involved in promoting them. 9:45 a.m. – SUPPORT – [HB 1233](#), prohibiting higher education institutions receiving state funds from requiring face masks and COVID-19 vaccinations for attendance. This bill would prohibit colleges, universities and the like from requiring the COVID jab or face masks to attend classes. [Click here to register your disposition](#). [Email the committee](#).

10:30 a.m. – OPPOSE – [HB 1332](#), excepting public universities and colleges from requirements under medical freedom in immunizations. This bill does the opposite of HB 1233 and essentially allows colleges, universities and the like to discriminate against students who practice medical freedom. 2:45 p.m. – SUPPORT – [HB 1588](#), relative to students attending public schools that mandate the wearing of face masks without an emergency order in place. This bill allows students to transfer from a home school district that requires masks to a district that doesn't require masks at the expense of the home district. Hearings for the following postponed bills have either been rescheduled as follows or remain unscheduled:

[House Committee of Children and Family Law](#)**Representative's Hall, State House, Tuesday, Feb. 8, 2022**

SUPPORT – [HB 1431](#), establishing the parental bill of rights. With masking at schools against parents wishes, the overactivity of DHHS, recently in the case of JR Hoell, and other state encroachment into parental rights in other examples too numerous to cite, it is high time that the People's Legislature create legal barriers to this state encroachment. UNSCHEDULED — SUPPORT — [HB 1131](#), relative to facial covering policies for schools. This bill prohibits schools, whether public or private, from creating policies that force students or members of the public to wear masks. [Email the committee](#).

UNSCHEDULED — SUPPORT — [HB 1371](#), relative to school district policies on facial masks of students in schools. This bill leaves the choice of whether to wear a mask up to parents and students and prohibits bullying that encourages mask wearing. [Email the committee](#).
