3PM TODAY! Tell Your County Prosecutor: Indict Fauci & Gang

The Constitutional Law Group is organizing a **national day of action today (2/14, 3PM)** with the aim of having citizens like us deliver a **Proposed Indictment** document to our county prosecutor,s along with Dr. David Martin's 200-page Fauci Dossier. The dossier contains much of the core evidence that any prosecutor could need to indict a number of bad actors including Fauci. Those interested in joining the indictment action on February 14th should meet me at Bank

of America (20 Central Square, Keene) at 2:30 pm to get our petitions notarized (recommend arriving earlier to give time for all to get their notarizations) and then proceed together to the County Courthouse (about 100 yards away) for 3PM to present the criminal complaints and the Fauci Dossier to the County Prosecutor.

RebuildNH's Deeper Look at Bills

<u>Watch Melissa Blasek</u> discuss this week's slate of legislation and actions you can take.

The full N.H. House of Representatives will vote this week on a few RebuildNH bills, one of which could use a little love from our activist team to push it across the finished line.

In particular, please <u>contact your state representatives</u> about <u>HB 1604</u> (including state medical facilities in the statute providing medical freedom in immunizations), and ask your reps to support the committee recommendation. This bill repeals the exemption of government nursing homes, hospitals and medical facilities from the statute pertaining to medical freedom in immunizations and would protect workers of these organizations against medical discrimination.

In addition to <u>HB 1604</u>, the House will vote on <u>HB 1608</u> on the Consent Calendar, which means the committee believes the bill has enough support to pass without objection. Please take no action at this time on <u>HB 1608</u> (requiring the department of health and human services to contact certain individuals whose information was included in the state immunization registry), but note that it is moving forward.

Two additional bills received favorable recommendations from their committees, but will not be voted on until a later House session. Feel free to <u>contact your state representatives</u> in support of these bills:

HB 1425, relative to the taking of real property by eminent domain. This bill would require the government to compensate a private property owner for any property taken during a state of emergency for public purposes, and it would provide other protections so eminent domain cannot be abused.

HB 1490, relative to equal access to places of public accommodation regardless of

vaccination status. This bill would give a person's "vaccination status" or masking choice a protected status in the state's civil rights law.

This Week's Headliner

SUPPORT – HB 1379, relative to the department of health and human services' rule-making authority regarding immunization requirements. This bill would remove authority from the Executive Department of Health and Human Services to determine what vaccines children must receive to go to school, and restore the Legislature's sole authority as the lawmaking branch of government to determine what vaccines ought to be required (religious and medical exemptions in other laws would still apply). We cannot have Executive Branch bureaucrats deciding what ought to be law in our state, particularly with something this important; this is a Constitutional authority that should be decided by the Legislature alone. Please <u>contact the committee</u> and let them know that you want the power to pass laws regarding required vaccines restored to the Legislature.

9:30 a.m. - OPPOSE - HB 1481, repealing the statute relative to medical freedom in immunizations. Here's another from <u>Progressive Rep. Tim Horrigan</u>, who apparently thinks the government ought to be able to force you to take a vaccine. On efforts like this, it's not just the bill that needs to be defeated; we need to take special note of the sponsors and make sure they lose the power of elected office come next election. In America, we don't force people to inject untested liquids into themselves. Click here to register your disposition. Email the committee. **10:45 a.m.** — **SUPPORT** — **HB 1379**, relative to the department of health and human services' rule-making authority regarding immunization requirements. This bill would remove authority from the Executive Department of Health and Human Services to determine what vaccines children must receive to go to school, and restore the Legislature's sole authority as the lawmaking branch of government to determine what vaccines ought to be required (religious and medical exemptions in other laws would still apply). Please contact the committee and let them know that you want the power to pass laws regarding required vaccines restored to the Legislature. Click here to register your disposition. DON'T FORGET: Email the committee. 1 p.m. - WATCH - HB 1271, limiting the authority of the department of health and human services to mandate vaccinations; and relative to quarantine costs. This bill would improve the law so the Commissioner of the Department of Health and Human Services could not force immunization without a 2/3rds vote of the Legislature. We aren't outright supporting this bill because we believe that no one, Legislature included, has the authority to force vaccinate

2:15 p.m. – SUPPORT – HB 1495, relative to vaccine mandates for government contractors. This bill establishes a chapter of law prohibiting employee vaccine requirements for government contractors, except for medical providers when there is a direct threat present. We believe that the exception ought to be amended out of the bill, but importantly, the bill does not force anyone to get vaccinated. Exemptions are still available for medical providers within the bill's language. Click here to register your disposition. Email the committee.

House Committee of Children and Family Law

11:15 a.m. — SUPPORT — <u>HB 1280</u>, prohibiting a parent's refusal to vaccinate a child pursuant to an order of the state or federal government to be used as a basis for terminating parental rights. This is a critically important bill that protects parents' rights from leftists in DHHS attempting to punish parents who don't vaccinate their children by threatening to take their children away from them. <u>Click here to register your disposition</u>. <u>Email the committee</u>.

House Committee on Executive Departments and Administration

Legislative Office Building, Room 306

2 p.m. — **SUPPORT** — <u>HB 1395</u>, relative to administrative rulemaking authority. This bill would take a giant leap in the right direction by requiring the whole Legislature to approve or reject recommendations to support or oppose administrative rules proposed by Executive Branch of government. At the end of the day, the Administrative Procedures Act should be repealed all together, but this bill would reestablish Constitutional Legislative authority in a major way. <u>Click here to register your disposition</u>. <u>Email the committee</u>.

House Committee on Health, Human Services, and Elderly Affairs Legislative Office Building, Room 205

10:15 a.m. – SUPPORT – HB 1606, making the state vaccine registry an opt-in program. This bill would require the state to receive permission from citizens before entering their private medical information into the state's vaccine registry, which complies with Part 1, Article 2B of the State Constitution. House Committee on Municipal and County Government

11:30 a.m. — SUPPORT — <u>HB 1268</u>, limiting the authority for city council bylaws and ordinances. This bill changes the enabling statute that allows cities and towns to pass "any" ordinance to only allow cities and towns to pass those bylaws and ordinances that the

Legislature has empowered them to make. This law is the way New Hampshire has always operated until the pandemic, when various cities and towns abused their authority and passed several unlawful public health laws; for example, ordinances that forced citizens to wear masks. Citizens should not have to consult a law book when they cross town lines, and this bill would ensure they are protected by uniform laws across the state. Click here to register your disposition. Hearings for the following postponed bills have been rescheduled as follows. Please plan to be there!

House Committee on Education

9 a.m., Feb. 25, 2022, State House Representative's Hall — SUPPORT — <u>HB 1131</u>, relative to facial covering policies for schools. This bill prohibits schools, whether public or private, from creating policies that force students or members of the public to wear masks. <u>Email the committee</u>.

10 p.m., Feb. 25, 2022, State House Representative's Hall — SUPPORT — <u>HB 1371</u>, relative to school district policies on facial masks of students in schools. This bill leaves the choice of whether to wear a mask up to parents and students and prohibits bullying that encourages mask wearing. <u>Email the committee</u>.




