



This Week's Headliners

We're asking for your special attention on three bills this week. If you're short on time, please be sure to email the committees YOUR opinion on these three bills. If you have more time, emailing the committees on all the bills we've included in today's email will go a long way to help advance our pro-liberty agenda this year. Please look below for more details, but here's the summary:

SB 374: This Senate bill would prohibit vaccine mandates. Let's give the Senate some love and encourage them to support this effort!

9:45 a.m. – OPPOSE – <u>SB 390</u>, relative to telemedicine and telehealth. We're concerned this bill could be lobbyist driven and the Senators don't understand what it does — we have to give them the benefit of the doubt, because **this bill is EVIL**! This bill would prohibit telemedicine from any practitioner not licensed in New Hampshire, which would cut-off effective COVID treatments from people who have been receiving them from out-of-state telemedicine doctors. The N.H. Legislature does not have the authority to regulated interstate commerce, because this power is delegated to the U.S. Congress in the U.S. Constitution, and thus we believe this bill is unconstitutional! Please <u>email the committee</u> and ask them to kill this horrible, horrible bill. <u>Click here to register your disposition</u>.

10:30 a.m. — **SUPPORT** – <u>SB 374</u>, relative to the SARS-CoV-2 vaccinations. Three cheers to the Senators who crafted this legislation; this one gets it right! This Senate bill would prohibit vaccine mandates, and it would do so quite effectively. Let's give the Senate some love and encourage them to support this effort! Thursday, Feb. 10, 2022 | N.H. House of Representatives <u>House Committee Of Labor, Industrial and Rehabilitative Services</u> Legislative Office Building Room 207

10 a.m. — SUPPORT – <u>HB 1143</u>, relative to medical mandates adopted by employers. This bill requires employers who institute vaccination mandates to submit their policy to the state for review and grant severance pay to any employee who refuses to submit. It's not the ideal solution, but we still want to be supporting all bills that assert how employer mandates are unethical and anti-liberty, and this one fits the bill. <u>Click here to register your disposition</u>. <u>Email the committee</u>.

10:30 a.m. — **SUPPORT** – <u>HB 1410</u>, relative to causes of action involving private business entity policies requiring employees or customers to receive medical treatment. This is a great bill that makes employers liable for the negative impacts of any vaccination mandate they impose in the workplace. UPDATE ON POSTPONED BILLS

Hearings for the following postponed bills have either been rescheduled as follows or remain unscheduled:

House Committee on Education

UNSCHEDULED – **SUPPORT** – <u>HB 1131</u>, relative to facial covering policies for schools. This bill prohibits schools, whether public or private, from creating policies that force students or members of the public to wear masks. <u>Email the committee</u>. **UNSCHEDULED** – **SUPPORT** – <u>HB 1371</u>, relative to school district policies on facial


masks of students in schools. This bill leaves the choice of whether to wear a mask up to parents and students and prohibits bullying that encourages mask wearing. <u>Email the committee</u>.
