1:15 p.m. —SUPPORT— HB 1431, establishing the parental bill of rights. With masking at schools against parents wishes, the overactivity of DHHS, recently in the case of JR Hoell, and other state encroachment into parental rights in other examples too numerous to cite, it is high time that the People's Legislature create legal barriers to the state's encroachment. The House passed amendment weakened the bill, but is still a step in the right direction. Nevertheless, the sponsors of the bill will be presenting an amendment to the senate that is even stronger than the original version. We're asking the committee to support the proposed amendment. 2:15 p.m. —SUPPORT—HB 1425, relative to the taking of real property by eminent domain. This bill would require the government to compensate a private property owner for any property taken during a state of emergency for public purposes, and it would provide other protections so eminent domain cannot be abused. 9 a.m.—SUPPORT—[HB 275](#), relative to the declaration of a state of emergency. This is the

language that we facilitated in an agreement between the House Freedom Caucus, Senators and the Governor in order to support the budget last year in [HB 2](#). The language that became law last year was an improvement from previous law, but it improperly theorized that a State of Emergency is the natural condition of government and requires both the House and Senate to vote to end it. We disagreed, and therefore pushed for the language in [HB 275](#) in exchange for supporting the budget. This language theorizes that a Constitutional Republic is the natural condition of government and that both the House and Senate ought to have to vote to continue a State of Emergency, and otherwise it should automatically end. 9:40 a.m.—SUPPORT—[HB 1487](#), relative to the procedure for withdrawal from the vaccine registry. This bill asserts that individuals have the right to remove their names or their children's names from the vaccine database without their doctor's approval, which is a stipulation the Department of Health and Human Services is attempting to assert through rule-making. 10 a.m.—SUPPORT—[HB 1466](#), relative to the off-label use of prescription drugs and relative to pharmacy prescriptions. Many health providers will not consider prescribing safe, effective drugs (like ivermectin) for the treatment of COVID-19 because they fear disciplinary action by licensing boards. 10:20 a.m.—SUPPORT—[HB 1099](#), prohibiting the department of health and human services from requiring vaccine passports for services. While this bill could be broader to prohibit discriminatory vaccine passports across the board, it is a start to prohibit the State from getting involved in promoting them. 10:40 a.m.—SUPPORT—[HB 1439](#), relative to hospital visitation policies. This bill allows, with limited exception, a patient to designate a parent, spouse, family member, or other caregiver to be present while the patient receives hospital care. We believe the exceptions should be eliminated from this bill, and would urge you to ask the committee for an amendment to remove them. 11:00 a.m.—SUPPORT—[HB 1241](#), prohibiting a school district from mandating a COVID-19 vaccination for school attendance. This bill's title says it all, and it's a good idea. Please [Click here to register your disposition](#). [Email the committee](#).

11:20 a.m.—SUPPORT—[HB 1495](#), prohibiting the state from requiring businesses to require

vaccine or documentation related to vaccination or immunity status. This bill establishes a chapter of law prohibiting employee vaccine requirements for government contractors, except for medical providers when there is a direct threat present. 11:40 a.m.—SUPPORT—[HB 1035](#), relative to exemptions from school vaccine mandates. If this bill passes, any required vaccination for school can be rejected as a matter of religious, conscientious, or medical objection, and this is how it should be! 12 p.m.—SUPPORT—[HB 1606](#), making the state vaccine registry an opt-in program. 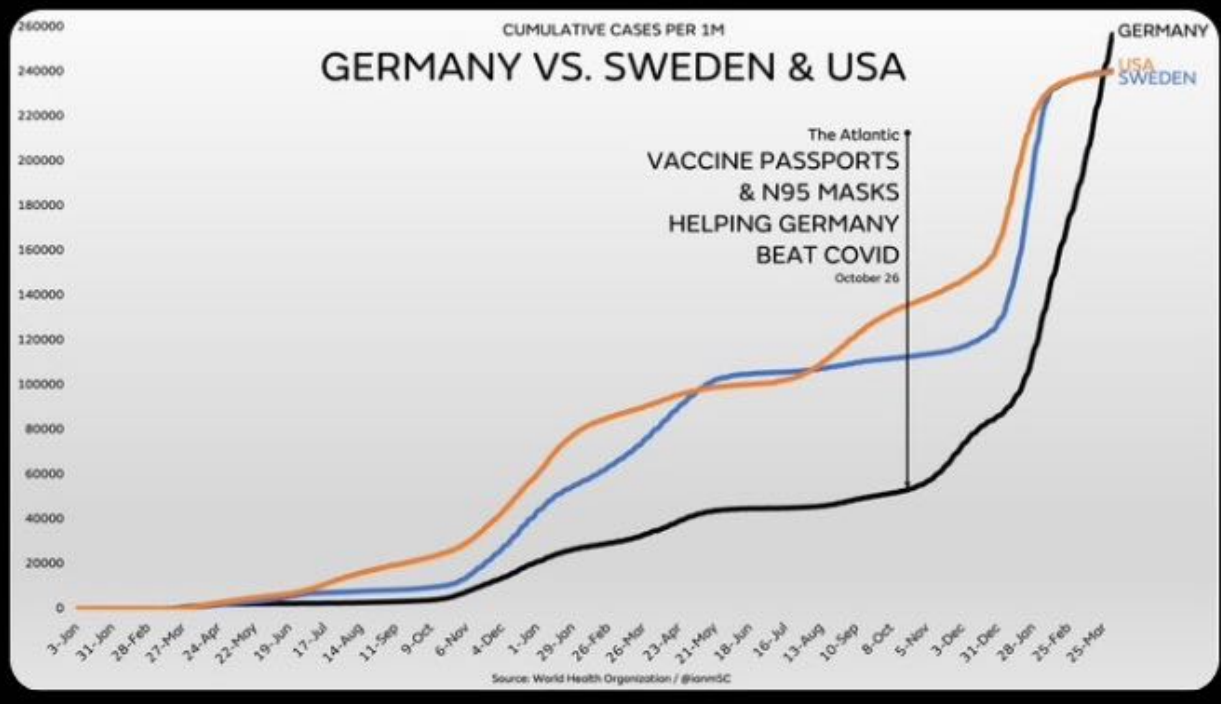

Dr. Theresa Long, a medical officer with the United States military, has testified in court that she was ordered by a superior to suppress **Covid-19 vaccine injuries** following the Biden regime's mandate.

The DoD downplayed Dr. Long's conclusions, saying the increase in **vaccine injuries** was caused by a "glitch in the database."

On March 10, Liberty Counsel, the law firm representing thirty members of the military who are fighting the **military vaccine mandate**, returned to federal court to defend the preliminary injunction Judge Steven Merryday granted two military plaintiffs that allowed them to skirt the **military vaccine mandate**.



The Department of Defense (DoD) asked the judge to set aside the injunction while the case was on appeal.

Judge Merryday is a United States District Judge of the United States District Court for the Middle District of Florida.

Per DailyExpose: During the all-day hearing, Liberty Counsel presented compelling testimony from the Navy Commander of a surface warship and three military flight surgeons, Lt. Col. Peter Chambers, Lt. Col. Teresa Long and Col. (Ret.) Stewart Tankersley, M.D. In contrast, the DOD declined to present witnesses.

Founder and Chairman of Liberty Counsel Mat Staver said in an interview with the Blaze's Daniel Horowitz on Monday that there have been three hearings now in this case, and the DoD has not yet offered a single witness. Instead of witnesses, the government "sends these declarations," Staver explained. He said the judge has urged them to bring live witnesses to court so they can be cross examined, but they just refuse to do it. "So they send these declarations that some JAG attorney writes, and somebody in the military signs off on them."

Staver said that the information the DoD has been presenting in court is "outdated, wrong, and would really be subject to dismantling under cross examination." He added that cross examinations of his witnesses have only made their case stronger. "So they really don't have anything to cross examine our witnesses with," he said.

Staver told Horowitz that Judge Merryday has chastised the DoD lawyers during the hearings, telling them they have "a frail case," and are "acting as though they are above the law."

Dr. Theresa Long, a flight surgeon who holds a master's degree in Public Health and is specially trained in the DMED, gave emotional testimony on March 10.

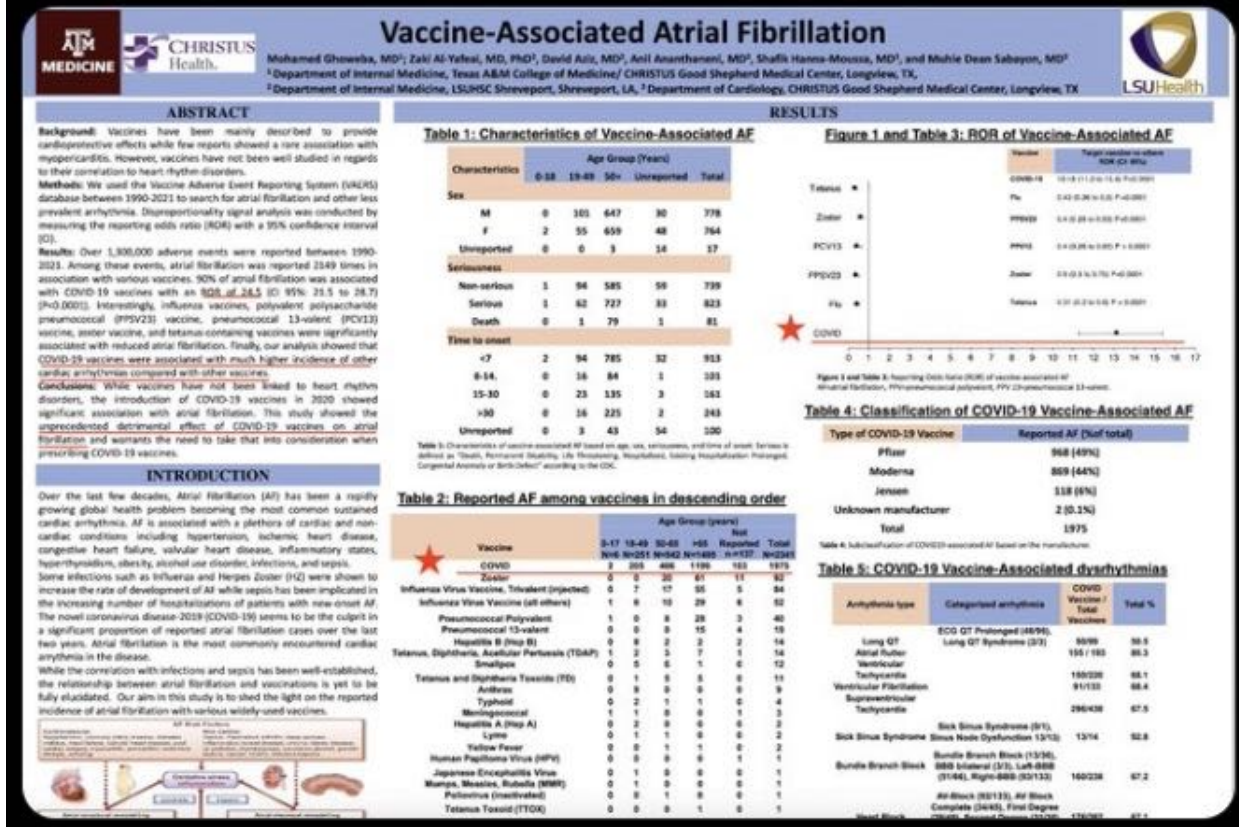

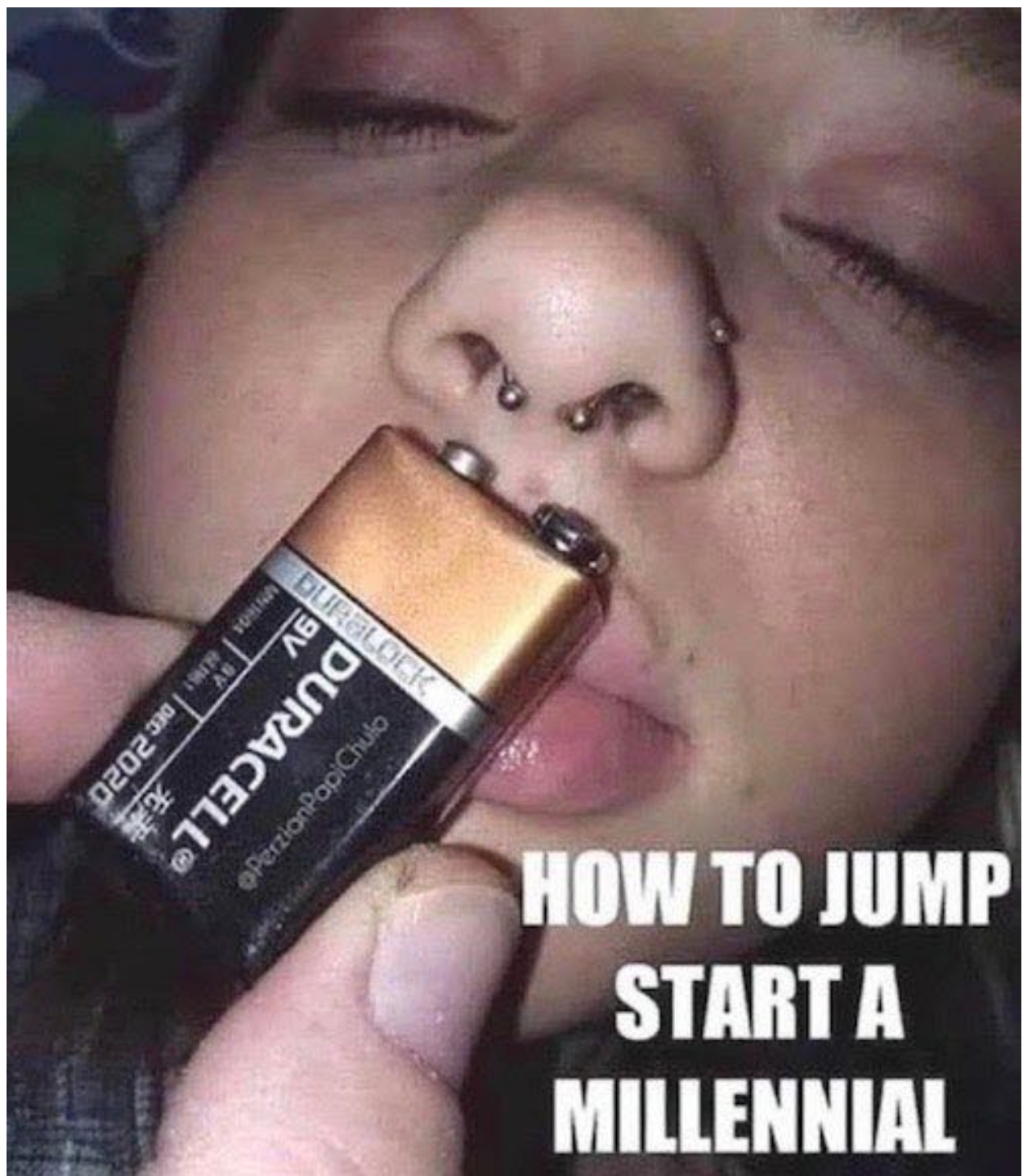
