#### Legislative Priorities from RebuildNH

#### Priorities for the week of May 1, 2022

Folks, you've made a huge impact. Thank you! The Senate has passed most of our promedical freedom efforts this year, and it has been a good year! There's one major effort left, and we're confident we can get it passed one way or another, but it would be better to get it through now. The hang-up, we've learned, is that Sen. Jeb Bradley and his friends in the Senate are more afraid of the lobbyists not paying for their re-election campaigns than they are worried about you, and we need to change that.

<u>Sen. Jeb Bradley</u> is still trying to kill <u>HB 1210</u> with an interim study. There's no need to study how employers abused employees and forced them to take an ineffective and unsafe vaccine that enriched a few Pharma execs and their stockholders. There's no need to study the principle that bodily autonomy is an individual right that no one can take away from you, and that it is the Legislature's job to protect that right from any actor who is trying to thwart it. The Senate needs to hear from you on this! Better yet, they need to see you!

The next Senate Session is taking place at 10 a.m. on Thursday at the State House in Concord, and it would be really great if you could fill up the gallery and respectfully make your presence known. A crowd outside the State House at 9 a.m. on Thursday would go a long way to helping get this bill passed. HB 1210 is the ONLY bill that helps protect employee rights to exemption from vaccine mandates this year. We understand you've already filled up his voicemail, so please **text Jeb Bradley—YES, AGAIN—directly on his personal cell phone: 603-387-2365** and explain that he works for the People of New Hampshire, not the lobbyists, and the People demand a law to protect our right to bodily autonomy.

# Please also email the full Senate and ask them to oppose the Interim Study and support an Ought to Pass Motion on HB 1210:

Here's some other talking points:

- 1. HB1210 is the ONLY bill that helps protect employee rights to exemption from vaccine mandates.
- 2. We need to eliminate the inquisition that many employees were put through in order to gain religious exemptions.
- 3. Individual rights trump the desires of corporations and lobbyists.

#### Senate Session: Thursday, May 5, 2022

We're very pleased with most of the Senate recommendations this week, and also that the Senate passed <u>HB 1131</u>, our bill to prohibit mandatory masks at schools—it's on the way to the governor's desk. That's HUGE! There is only one effort that we need your help with this week, and we detailed that bill and our activism request in our note above.

The Senate will be meeting to vote on the following bills at 10 a.m. on Thursday, May 5. We'd love it if you could come out to stand in front of the State House starting at 9 a.m. on Thursday to support our medical freedom efforts this week. If you bring a sign, please indicate that you support HB 1210 in your message.

**Oppose Interim Study, Support OTP**—<u>HB 1210</u>, relative to exemptions from vaccine mandates. The bill allows for a simple, streamlined exemption process (still medical, religious, and conscience) for businesses that receive any money from the state or federal government.

**Support OTP-A**—<u>HB 1022</u>, permitting pharmacists to dispense the drug ivermectin by means of a standing order. This would make ivermectin over-the-counter medicine in New Hampshire.

**Support OTP**—<u>HB 1099</u>, prohibiting the department of health and human services from requiring vaccine passports for services. While this bill could be broader to prohibit

discriminatory vaccine passports across the board, it is a start to prohibit the State from getting involved in promoting them.

**Support OTP-A**—<u>HB 1455</u>, relative to state enforcement of federal vaccination mandates. This is the Speaker of the House's bill to prohibit state officials from enforcing federal COVID-19 mandates.

**Support OTP-A**—<u>HB 1606</u>, making the state vaccine registry an opt-in program. This bill would require the state to receive permission from citizens before entering their private medical information into the state's vaccine registry, which complies with Part 1, Article 2B of the State Constitution.

**Support OTP-A**—<u>HB 1280</u>, prohibiting a parent's refusal to vaccinate a child pursuant to an order of the state or federal government to be used as a basis for terminating parental rights. This is a critically important bill that protects parents' rights from leftists in DHHS attempting to punish parents who don't vaccinate their children by threatening to take their children away from them.

**Support OTP**—<u>HB 1604</u>, including state medical facilities in the statute providing medical freedom in immunizations. This bill repeals the exemption of government nursing homes, hospitals and medical facilities from the statute pertaining to medical freedom in immunizations.






